

Privacy Policy

[MS. KUTACANE] and its subsidiaries and affiliates (“we”, “us”, or “our”) take seriously the protection of your personal data (generally meaning information and data that can identify you as a person). This Privacy Policy describes how we process information about you through our [Aloe Bud](“App” or “Services”).

I. What information do we collect?

The information we collect may include:

- email address.
- behavioral usage of the App.
- device identifiers (such as IDFA, IDFV for Android, GAID for IOS).
- the type and operator of network (such as Mac address).
- the type, version, brand, language and operating system of device.

II. How is children’s privacy and data?

The Services are not intended for use by anyone under 13 years of age. If you are a parent or guardian of a child from whom you believe we have collected personal information in a manner prohibited by law, please contact us. If we learn that we have collected personal information through the Services from a child without the consent of the child's parent or guardian as required by law, we will comply with applicable legal requirements to delete the information.

III. How we use information about you?

We may use information about you for the following purposes:

- analyze your usage of the Services, improve the Services, conduct research, improve the rest of our business.

- comply with applicable laws, lawful requests, and legal process.
- protect our, your or others' rights, privacy, safety or property.
- with your consent.

IV. When we disclose your information?

We may disclose information about you to certain other parties, as described below:

- To our affiliates for the purposes identified in this Policy.
- To other parties that provide, secure, promote, and improve our Services.
- To professional advisors, such as lawyers, auditors, where necessary in the course of the professional services that they render to us.
- To law enforcement, government authorities, and private parties, as we believe in good faith to be necessary or appropriate for the compliance and protection purposes described above.

V. Your rights.

You may have the right to request that we:

- Provide you the categories of personal information we have collected or disclosed about you.
- Delete certain personal information we have about you.
- Correct inaccurate personal information we have about you.
- Provide access to and/or a copy of certain personal information we have about you.
- Withdraw your consent.

VI. How we secure your information?

We employ a number of technical, organizational and physical safeguards designed to protect the information we collect about you.

VII. How long we retain your information?

We will retain your information for only as long as necessary to provide the Service and for the other legitimate business purposes set out in this Policy such as safety, security, compliance, and dispute resolution.
